

**Project Brief**

The office of the Labour Commissioner, Govt. of Odisha, is implementing the Building and Other Construction Workers (RE and CS) Act for numerous vulnerable construction workers of Odisha. The State has constituted an welfare Board namely Odisha Building and Other Construction Workers' Welfare Board w.e.f 2008 to exercise the power relating to this Act. The construction workers of Odisha are being registered under the Welfare Board as beneficiaries and different social security assistances like Bicycle Assistance, Safety Equipments Assistance, Working Tools Assistance, Education Assistance, Marriage Assistance, Housing Assistance, Pension Assistance etc as per the guidelines issued from time to time.

Out of the above benefits, claims for benefits like Bicycle Assistance, Safety Equipments Assistance and Working Tools Assistance are reimbursed after the purchase of goods and submission of bills by the workers to this office. After getting verification report on the genuineness of the bills from the concerned shops this office is disbursing the financial assistance to the workers. As day by day more numbers of beneficiaries are applying for these assistances, it is getting difficult for this office to verify the genuineness of bills from numerous shops. Hence to check the genuineness of purchased goods and to simplify disbursement process, the Welfare Board has decided to empanel the Shops/Agency district wise. The specified goods will be purchased by the eligible construction workers of Jagatsinghpur district from the **Empanelled Shops/ Vendors**.

Expressions of Interests (EOI) are invited from the eligible shops/ vendors for their empanelment as supplier of the above articles. The EOI should be submitted by 27.12.2018. The bid should reach to the office of the District Labour Officer, Jagatsinghpur by Speed post/ Registered Post only.

**ELIGIBILITY CRITERIA**

The following is the eligibility criteria for the Shops/ Vendors for shortlisting:

- ❖ The shops/vendor must have district presence.
- ❖ The shops / vendor should have PAN Number.
- ❖ The shops / vendor should have active GST number.
- ❖ Up-to-date Income Tax return.
- ❖ Up-to-date filing of GST return(GSTR:3B & GSTR1)
- ❖ Valid Registration Certificate under Odisha Shops & Commercial Establishment Act, 1956 for establishment/agency situated at urban area.

### **SUBMISSION OF EOI**

Organisations interested for short listing are requested to submit their Registration form ( **Form-I**) in a sealed cover superscribing "**For short-listing of Shop/ Agency for supplying of goods to Construction workers of Jagatsinghpur district**" and the same should reach on or before **27.12.2018** by **5.00 PM** at the address given below by **Speed Post / Registered** post only:


### **N.B.:**

- Details of experience, if any , certified copy of balance sheets, registration details of the office with address, copies of PAN/TAN no. etc. with **supporting documents** to be submitted with registration form.
- A declaration form to be provided as per **FORM-II**.
- Please note that, the applications NOT submitted as per the prescribed format / prescribed procedure shall be rejected.
- Applications NOT reached at the given address by **5.00 PM of 27.12.2018** shall not be considered.

### **PROCEDURE FOR SHORT LISTING**

- i) Application for empanelment will be opened and assessed by a Committee chaired by the PD, DRDA, Jagatsinghpur in the Office Chamber of PD, DRDA, Jagatsinghpur.
- ii) The Committee reserves right to commend amendments in the proposed project.
- iii) The decision of the Committee shall be final and binding on all the bidders.
- iv) Committee reserves the right to select one or more agencies / shops for each item subject to eligibility, compliance to quality, price term etc.

All the proposals, received by due date, will be scrutinised at **11 A.M. of 28.12.2018** to assess their eligibility based on the eligibility criteria in presence of all the applicants. Those proposals which do not meet the eligibility criteria will be summarily rejected by the Committee on the aforesaid date. Organisations/ Institutions/ Agencies will be short listed for the empanelment shall be issued **Request For Proposal (RFP)** for the work.
