OFFICE ORDER

In pursuance to the selection of candidates by the Odisha Sub- Ordinate Staff Selection Commission Communicated vide Letter No IIE-53/2018/1055(C)/OSSSC, Dt-12.12.2018 & Letter No IIE-53/2018/57(C)/OSSSC, Dt-18.01.2019, the following 05 nos candidates are hereby appointed as supervisor on contractual appointment in the consolidated pay Rs.16880/- P.M under PB-2.

This is in accordance with Odisha Group- B posts (contractual appointment) Rules, 2013. During the period of contractual appointment they shall draw monthly remuneration as per G.A Department Notification No GAD-SC-Rules-0037-2017-19569-Gen. dated 12.09.2017.

Appointment is purely on contractual basis initially to be guided by the Odisha Group-B posts (contractual appointment) rules,2013 notified vide G.A Department Notification No 1147-GAD-SC-Rules-0061-2013/GEN, Dt-17.01.2014.

The persons appointed in the post of supervisor shall continue on contractual basis for a period of six years. The period of six years shall be counted from the date of their contractual appointment.

During the period of contractual appointment they shall draw consolidated monthly remuneration as per Govt. in G.A Department Notification No GAD-SC-Rules -0037-2017-19569-Gen dated 12.09.2017 and an annual increase of remuneration shall be enhanced as per slabs prescribed in the above notification subject to satisfactory performance of the employee. Further they shall not be entitled to DA, HRA, RCM and other allowances during the period of contractual appointment.

They are entitled to have leave under the provision of the Odisha Leave rules, 1966 at par with regular employees of Govt. of Odisha.

Besides they shall be enrolled under the new pension Scheme contained in the Odisha Civil Services (Pension) rules, 1992 from the date of contractual appointment.

On the date of satisfactory completion of 6 years of contractual service, they shall be deemed to have been regularly appointed. A formal order of regular appointment shall be issued by the appointing authority.

The appointment is purely temporary and can be terminated at any time without notice or assigning any reason thereof.

They shall join the post within 15 days of issue of the order in the ICDS Projects as noted against each unfailingly.

Candidates are required to produce the following documents at the time of joining :-

1. Medical certificate of fitness from a government registered medical practitioner not below the rank of an assistant surgeon.
2. Certificate of educational qualification showing the date of birth.
3. Two character certificates issued by two gazetted officers.
4. Certificate to the effect that he/she has not more than one spouse living in case of married person.
5. Caste certificate in original in case of ST and SC candidate.
6. SEBC certificate in original in case of SEBC candidates.
7. Oath of allegiance.
8. No TA/DA is admissible to join the post.
