TENDER CALL NOTICE

Sealed tenders are invited from the intending executants/ firms having Service Tax Registration, Sale Tax, Income Tax & GST with valid labour license to take up following items of works to be executed at S.V.M. College, Jagatsinghpur premises for the ensuing Simultaneous General Election, 2019.

Item of Works :

- (i) Barricading of dispersal and receiving centre with overhead tent to be erected in (i) northern side of main building (ii) in front of gents hostel (iii) eastern side of main building
- (ii) Over head tent with dari/tarpoline in the ground for resting place of Polling personnel/ verification place of polling materials by polling personnel in front of the dispersal & receiving centre mentioned above.
- (iii) Over head tent near S.V.M. College auditorium for Police personnel.
- (iv) Supply of Tables and Chairs for respective counters for dispersal/ receiving centre and counting hall.
- (v) Barricading in front of S.V.M. College for counting of votes (For Law & Order)
- (vi) Barricading/ Net Fencing inside the counting hall.

Light arrangement :

- (i) Light arrangement inside/outside of dispersal and receiving centre.
- (ii) Light arrangement around the premises of S.V.M. College.
- (iii) Light and Fan provision inside the Office room/ Store room to be set up in S.V.M. College.
- (iv) Provision of supply of power to Computer/ Fax/ Printer etc to be set up for dispersal/ receiving and counting including High power Generators as required in all dispersal/ receiving centres and counting hall.

Sound arrangement :

- (i) Vehicle counter (one set) from 26.04.2019 to 30.04.2019
- (ii) Dispersal centre (Three sets) on 27.04.2019

- (iii) Receiving centre (Three sets) on 29.04.2019
 (iv) Information counter (One set) on 27.04.2019 & 29.04.2019

Besides, the bidders shall provide/ erect/ make any other arrangement as would be required by the authority on the dispersal/ receiving and Counting hall.

- Rates should be quoted per Sqft. for the entire process in respect of Tents.
- Separate rate shall be quoted for other items.
- However, the bidder shall also quote rate for all the above composite items taken together.

All above item of rate shall be quoted in the prescribed format mentioned below.

The tender shall be received by the District Election Office, Jagatsinghpur, on behalf of the Collector, Jagatsinghpur during office hour on working days from **Dt. 18.03.2019 (10.AM) to 26.03.2019 (12 Noon) only through REGISTERED/ SPEED POST** in the District Election Section, Collectorate, Jagatsinghpur. Tender document sent in any mode other than the above prescribed mode shall not be entertained in any circumstances. The District Election Officer, Jagatsinghpur, shall not be responsible for any postal delay. Tender paper received after the scheduled date and time along with telegraphic and conditional tender shall not be accepted. The tender will be opened on 26.03.2019 at 4 P.M. in the Office chamber of the Addl. District Magistrate, Jagatsinghpur in presence of the Procurement Committee members and quotationers or their authorised representatives.



TERMS & CONDITIONS OF TENDER CALL NOTICE

01. The organization should have PAN and GST holder. Attested copies of PAN Card & valid GST registration certificate should be attached.
02. The bidder must not have been blacklisted by any Govt. organization.
(Attach declaration in Stamp Paper of Rupees Ten)
03. The tender must be accompanied with a Demand Draft of Rs. 50,000.00 (Rupees Fifty Thousand) only in favour of Collector, Jagatsinghpur as EMD. The draft be made in favour of Collector, Jagatsinghpur in any nationalized bank payable at Jagatsinghpur.
04. The tenders without EMD will be liable for rejection.
05. The EMD of unsuccessful bidder will be returned without interest on finalization of bid.
06. If any dispute arises, the matter shall be referred to purchase committee for settlement of dispute.
07. The price quoted by the bidders shall be valid for the period of one year from the date of signing of agreement/ finalization of the tender.
08. The quotations received in incomplete form or after the scheduled date & time shall be summarily rejected.
09. Failure to execution of work in time on the part of the successful bidder will entail forfeiture of the earnest money.
10. The authority reserves the right to reject any or all the tenders without assigning any reason thereof and shall bear no liability what so ever consequent upon such decision.


