After cancellation of the previous Tender , again sealed tender is invited from intending regd. Firms/NGOs /Private companies/Government contactors/Registered Municipal Contractors/ regd. Service provider/ regd. outsourcing agency for supply of contact labour & workers proposed to be engaged in sanitation related work for Jagatsinghpur Municipality for financial year 2019-20. The stipulated time period of contacts will starts after execution of agreement.

The paper cost of (Rs 4000+ GST Rs 720) Rs 4720/- in shape of bank draft of any nationalized bank pledged in favour of Executive Officer, Jagatsinghpur Municipality, Jagatsinghpur must be given failing which the tender will be rejected automatically.

The tender paper will be available between dt. 06.12.2019 to dt. 20.12.2019.The tender paper can be dropped in the sealed tender box available in office of the undersigned on dt.21.12.2019 by 5.P.M and can be received through regd. Post/ speed post of India post within dt. 21.12.2019 by 5.P.M. The tender will be opened on 23.12.2019 at 3.30 P.M in presence of tenderers or their authorized representative if present. For any postal delay the Municipality is not responsible.

The successful bidder will have to deposit @ 1% of the quoted monthly (31 days) tender value in the shape of Bank draft as initial 'security deposit' before issue of work order & agreement and it will be refunded after completion the closure of contract / expire of bid period. No interest will be paid on the security money deposited by the successful bidder

Eligibility criteria

{To be submitted in chronological manner i.e. from Srl. (a) -(m)}

The Tender should be accomplished with (a) Offered quoted rate of unskilled, semi skilled & skilled worker separately (b) Paper Cost (c) Copy of PAN Card (d) copy of GST (e) Copy of Labour License clearly specified to deploy minimum 100 nos of labourers & above (f) Copy of PF regn. Certificate (g) Copy of ESI regn. Certificate (h) Service tax registration certificate (i) Income Tax return of last three years (j) Service Tax return of last three years.(k) The tenderer/bidder should submit the experience certificate minimum of two years in execution such type of work in ULB. .(l) The tenderer have to give a proof regarding office/branch office within

Jagatsinghpur District.(m) The Affidavit stating that all the documents submitted are true and will work connecting to sanitation governed under different Act & Rule framed thereunder.

The service provider is responsible to supply the workers/ labourers who will worked in shift basic. Apart from this service provider may be asked to supply the workers as and when required. The authority has a right to cancel the contact by issuing notice.

The contractor/Service provider will quote their service /administrative charges over and above the rate as per the Bill of quantity for Tender. After satisfying the eligibility criteria only as above , the quotationer/Tenderer can participate in the financial bid as given in the 'Bill of quantity for Tender'. The total offered rate will be considered instead of single offer rate of each category of workers. Apart from this the service provider will deposit the wage ,statutory dues of the workers and also provide the safety equipments & other entitlements to the workers. After payment by the service provider, Municipality will disburse the same to the agency.

The successful bidder /tenderer will execute the agreement with the Municipality by specifying terms, conditions including duties and responsibility of the successful bidders in details. However the authority reserves the right to reject any or all the tenderers without assigning reason thereof.
