**ORDER**

**Whereas**, the National Disaster Management Authority, Govt. of India in exercise of power conferred under section 6(2) (i) of the Disaster Management Act-2005 has directed the State Govt./State Authorities to take measures to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary guidelines in this regard.

**And Whereas**, Govt. of Odisha in exercise of powers conferred under section 2,3 & 4 of the Epidemic Diseases Act, 1897 has promulgated Odisha COVID-19 Regulation, 2020 for containment and spread of COVID-19.

**And Whereas**, Govt. of Odisha has issued various measures to contain the spread of COVID-19 through orders from time to time.

**And Whereas**, ten nos of positive cases of COVID-19 have detected in District Court complex, the area that requires detailed measures for active contact tracing, quarantine, aggressive testing and isolation. To facilitate this, it is necessary to make the area as a containment zone and to restrict the movement of public from entering into and going out of the containment zone.

**Now therefore**, in larger public interest with a view to contain the spread of COVID-19, I Sangram Keshari Mohapatra, O.A.S. (S.A.G.), Collector and District Magistrate, Jagatsinghpur being the empowered officer do hereby direct to implement following orders:

**1-The area of District Court Complex, Jagatsinghpur from the connecting road** from Charchika Bazar to Chandura Road is hereby declared as containment zone as per map enclosed.

**2- All vehicular movement, movement of public transport and personnel movement will be stopped.**

3- All the inhabitants within the containment zone shall strictly remain in home. All the shopping establishment whatsoever nature shall be closed immediately. The supply of essentials and medical requirements will be ensured through various teams formed by Jagatsinghpur Municipality.


4- All the Govt. and Private institutions located within the boundary of the containment zone is hereby closed forthwith.

Jagatsinghpur Municipality is hereby instructed to take necessary action for the said purpose.

Dr. Saroj Kumar Sarangi, HMO, Jagatsinghpur Municipality with mobile no. 9437128504 is hereby declared as nodal officer for smooth implementation of containment zone activities.

This order comes to effect immediately and the containment will continue for 7days upto dt. 27-09-2020.


**Any violation of this Order shall attract penal provision under Disaster management Act 2005 and Sec 188 of IPC.**






