3. Supply of NSPGY Logo tiles (Ceramic) (15 X 15 Inch with 6 mm thickness) under Nirman Shramik Pucca Ghar Yojana and delivery at all 8 Blocks of Jagatsinghpur district as per design types & specifications given by this Office.

1. The bidders must be a reputed firm/ Agency.
2. The bidder must have similar work experience.
3. The bidder can submit only one Bid. Multiple Bids submitted by any bidder shall result in rejection of all his/her bids.

5. The bidder must have minimum turnover worth Rs. 20 Lakh during the last 3 (three) financial years. Copy of ITR of the firm for corresponding financial year/ copy of the Audited Financial Statement of last three financial year duly attested by the Chartered Accountant should be attached with the application.
6. The quotation shall be submitted in a sealed envelope/cover and **superscribed with "Supply of PMAY(G)-BPGY,BPGY & NSPGY Logo tiles under PMAY(G)-Biju Pucca Ghar Yojana & Nirman Shramik Pucca Ghar Yojana" to D.R.D.A., Jagatsinghpur.**
7. The quotation shall remain valid for a period not less than One Year after the deadline date specified for submission.
8. The quotation duly filled in with all required documents should reach the Office of The Project Director, DRDA, Jagatsinghpur latest by 5.00 PM on **27/11/2020**. The sealed quotations received within the deadline will be opened on **01/12/2020** at **3.00** PM in the Office Chamber of Project Director, DRDA, Jagatsinghpur in the presence of the committee member and bidders or their authorized representatives .Any quotation received after due date will be out rightly rejected. DRDA, Jagatsinghpur will not be responsible for any postal delay or misplacement of the document.
9. The bidder / representative of the bidder must submit a sample PMAY(G)-BPGY, BPGY & NSPGY logo tile as per specification during the opening of the tender document.
10. Intending firms/suppliers may submit the quoted price in the prescribed Performa enclosed as **Annexure-A** along with copy of GST registration certificate, PAN card & all other required documents as specified in the Tender Advertisement.
11. The rate quoted should be inclusive of all taxes and other dues like transportation cost up to the delivery point i.e. all 8 Block Headquarters of Jagatsinghpur District.
12. The selected bidder has to supply of the items within 30 days from the date of issuance work order.
13. The purchaser will examine, evaluate and compare the quotations received from the responsive Bidders and select the L₁ bidder taking in to consideration the lowest price quoted for all items taken together.
14. The bidder whose bid is accepted will be notified of the award of contract by the purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
15. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.

20. The supplier should submit the Bank account details for transfer of funds.
21. The selected suppliers will execute an agreement at DRDA level for supply of listed materials for one year with a fixed price as agreed in the tender process with given specifications.
22. Before acceptance of tender, the successful bidder will be required to submit a work programme and milestone basing on the physical & financial achievement so as to complete the work within the stipulated time and case of failure on the part of the agency to achieve the milestone, liquidated damage at the applicable rate will be imposed.

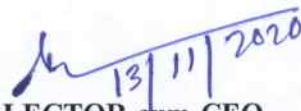

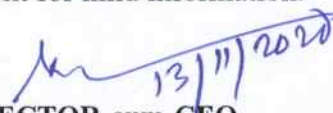

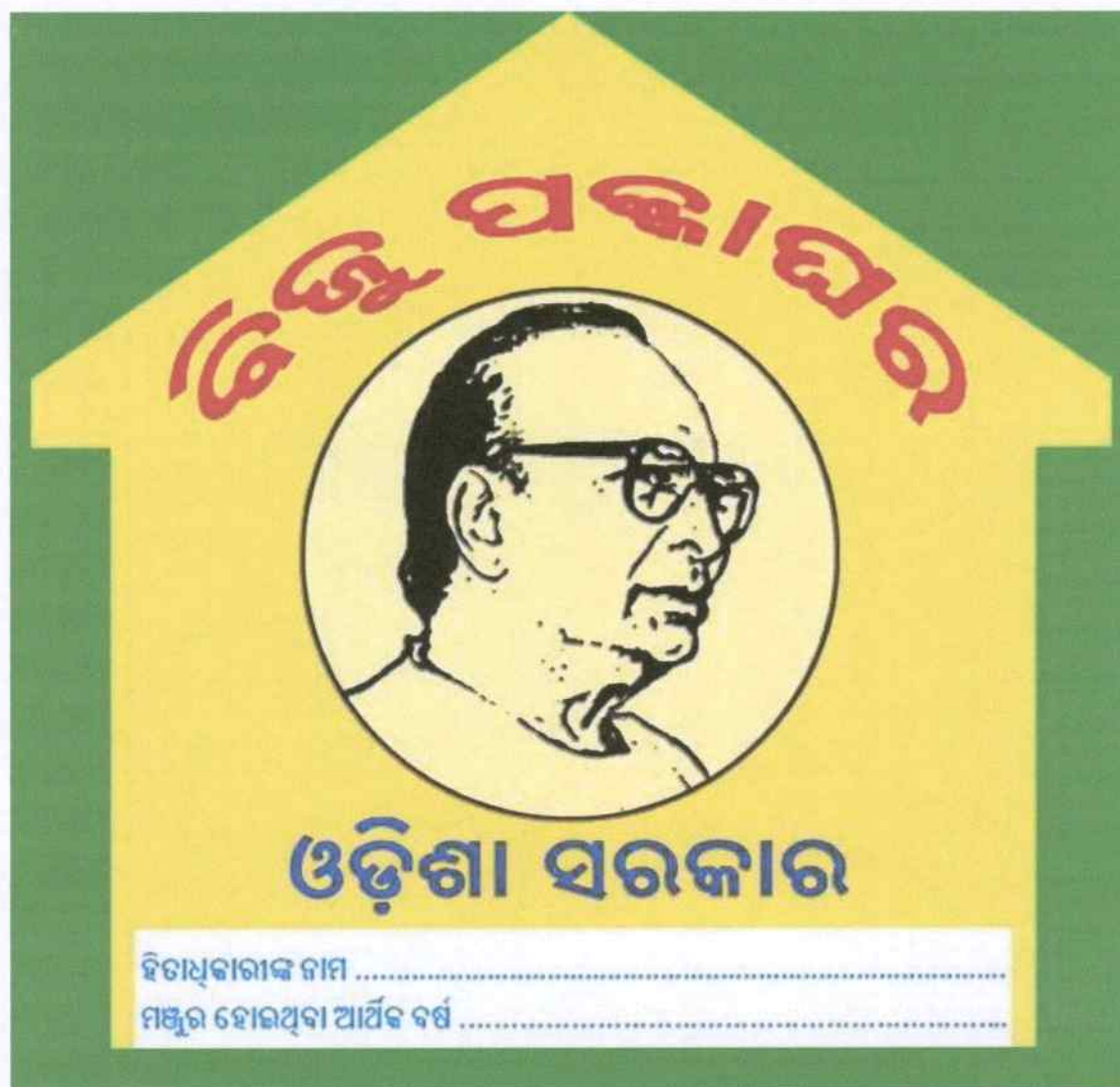
