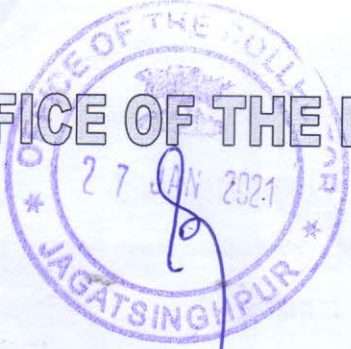

As per Letter No 29, dt. 11.01.2021 of Collector & District Magistrate, Jagatsinghpur, I do declare my property details (movable & Immovable) in public domain.

I had joined the Odisha Administrative Service on 05.03.1999 and this is my 22nd year of Service. I had regularly submitted my property returns to Government in time through HRMS.

I do submit my immovable and movable property till 31st Dec 2020 as detailed bellow.

A. Immovable Property

I. Lands:

- Ac 0.105 decimal of land at Mouza- Chandaka was purchased in favour of my wife on 08.08.2008 with cost of Rs. 1,91,058.00.
- Ac 0.140 decimal of land at Mouza - Markandpur, Tahasil- Jagatsinghpur and 0.140 decimal of land at Mouza - Deuligrameswar, Tahasil- Jagatsinghpur was recorded in favour of my father and mother respectively and this land was purchased more than 40 years back.

II. Houses

- 2300 Sqft building over Ac 0.100 decimal of land at Mouza - Bhubaneswar sahar, unit- 36, Rajarani is recorded in favour of my wife. The building was constructed out of bank loan taken from Indian bank, GPF withdrawal, mother's contribution from her gratuity/ Pensionary benefits and contribution of my wife from her business and the monthly EMI is Rs. 33,000.00.
- 2500 Sqft building at Mouza- Rajarani, Bhubaneswar and 2800 Sqft building at Mouza- Kherasa, Jagatsinghpur was recorded in favour of my father & mother respectively. This was constructed 40 years back.

B. Movable Property

- I. Bank Balance
 - Bank balance is less than Rs. 1, 00,000.00 of me, my wife and my children in all saving account together.
- II. Fixed Deposit : Nil
- III. Gold : 100 gram
- IV. Insurance Policies : Rs. 73,237/ Per Year
- V. NPS : Rs. 50,000/ Per Year (deposited since 3 years)
- VI. Vehicle :
 - One Hyundai I-20, Sportz four wheeler vehicle having Regd No. OD- 33 E 9577 was purchased on 24.11.2015 an amount of Rs. 8, 45,093.00 by taking loan of Rs. 7, 00,000.00 from HDFC Bank.
 - One Motor bike having Regd No. OR-O7P-7573 was purchased during 2007 with an amount of Rs. 45,000.00.
- VII. Other Assets :
 - Fridge, TV, AC, Washing Machine, Sofa, Dining Table etc. All were shown in my annual property statement.
