The Quotation(s) received beyond the scheduled date and time will summarily be rejected.




1. The intending registered Printing Press/ Supplying Agencies must be bonafide registered body having valid registration number. Attested photocopy of the registration certificate should be attached.
2. The organization should have PAN, valid GST number and up to date GST clearance certificate. Attested copies of PAN, valid GST number and GST clearance certificate should be attached.
3. Rate should be quoted inclusive of GST charges, printing, fixation and delivery charges etc. The defective and damage printing materials if any must be replaced by the printing organization.
4. The Quotation paper should be filled in properly and eligibly without any correction/ overwriting. The rate per units should be written both in figures and words in the Quotation Form i.e. Financial Bid (placed at **Annexure-B.**)
5. All the IEC materials will have to be delivered/ fixed at respective places as mentioned in Annexure-A within the stipulated time at their own cost. The transportation charges, loading and unloading & fixation of materials shall be borne by the supplier.
