

1. That, I am a permanent resident of Odisha in the above noted address.
2. That, in english version my surname has been wrongly mentioned as 'Raut' instead of 'Rout' in my Voter ID and also my husband's has been wrongly recorded as Shankar Raut instead of 'Sankar Charan Roul'. But in my Aadhar card & other documents my surname has been correctly mentioned as 'Rout' i.e. Kiranabala Rout, and also my husband's name has been mentioned in his Aadhar card and other documents as 'Sankar Charan Roul' and his surname has been wrongly mentioned as 'Raul' instead of Roul.

3. That, due to spelling mistake my husband's name has been mentioned in his Voter ID as 'Shankar Charan Raut' instead of Sankar Charan Roul.


