As per Letter No 210 (10) dt .13-7-2022 of Joint Director of A.H & V.S Sealed tender is hereby invited from intending regd. Firms/NGOs, Service provider/ regd. outsourcing agency to provide **one number of Contractual Veterinary Doctor having experience on ABC programme & one number of Contractual ABC Assistant** (with two years diploma in animal sciences) to be engaged for implementation of ABC Programme within Jagatsinghpur Municipality as per requirements:

2. The stipulated time period of contacts will starts after execution of agreement.

The non refundable paper cost of (Rs. 6000/- + GST of Rs. 1080/-) = Rs. 7080/- (Rupees seven thousand & eighty only) in total will be deposited in the shape of Bank draft in favour of Executive Officer, Jagatsinghpur Municipality, Jagatsinghpur. failing which the tender will be rejected automatically. The successful bidder will have to deposit 1% of the total quoted monthly (31 days) wage rate of each category of workers in the shape of in shape of STDR/NSC duly pledged in favour of Executive Officer, Jagatsinghpur Municipality as initial EMD before issue of work order & agreement. The EMD will be refunded after completion / closure of contract / expire of bid period. No interest will be paid on the security money deposited by the successful bidder.

The Tender call Notice, eligibility criteria, bill of quantity (BOQ) may be downloaded from the District website i.e. www.jagatsinghpur.nic.in. The quotationer / tenderer is advised to download the Tender paper from the website to quote their offer rate in the BOQ . It is to state here that the BOQ must be kept in one envelop & other tender papers & paper cost in another envelop. Then these two type of envelops will be kept in one envelop which can be received through Indian regd. Post/ speed post on dt. 25-7-2022 by 5.P.M .The tender will be opened on 26-7-2022 .at 11.00 A.M in presence of tenderers or their authorized representative, committee members and authorities . For any type of postal delay the Municipality will not be held responsible. Bid papers received through by hand or courier will not be accepted.


The Tender papers should be accomplished with (a) Paper Cost (b) Copy of PAN Card (c) copy of GST (d) Copy of Labour License (e) Copy of EPF regn. Certificate (f) Copy of ESI regn. Certificate (g) Income Tax return of last three years (h) The tenderer / bidder should submit the certificate of two years continuous experience in execution of such type of work in any ULB. .(i) The tenderer have to give a proof regarding office/branch office within Jagatsinghpur District.(j) The Affidavit must be given stating therein that all the documents/ papers submitted in the tender paper are true, valid and in force (k) The tenderer/ bidder Should submit the recognition letter of AWBI. This agency has not been black listed by Govt. or it approved bodies .There is no prohibition/ restrictions/ restrain order passed by any court of law against the agency to participate in this nature of work connected to this tender .In case of falsification the agency is liable for punishment.

The service provider is responsible to supply the manpower who will worked as per agreement. Apart from this service provider may be asked to supply the manpower as and when required. The Service provider must be in readiness to perform the work connecting to

ABC programme governed under different Act & Rule framed thereunder and as per the instruction of authorities.

Those are eligible/ successful after finalization of papers submitted as per the eligibility criteria, can only participate in the financial bid as given in the 'Bill of quantity'. Apart from this the service provider will deposit the wage, statutory dues of man in position and also provide the safety equipment's & other entitlements to them as per norms of Govt. After payment by the service provider, Municipality will disburse the same to the service provider. However any damage to life or property during duty hour will be borne by the service provider.

The successful bidder /tenderer will execute the agreement with the Municipality by specifying terms, conditions including duties and responsibility of the successful bidders in details. The bidder should provide mail ID, contact No. and postal address for any correspondence. The authority shall reserve the rights to cancel or reject or modify the tender papers/ quotation papers/ agreement without assigning any reason thereof & without any notice.






