The envelope carrying the bid/tender must be superscribed in capital letter with (OFFER FOR AUCTION SALE FOR VEHICLES)

The intending tenderers are advised to inspect the above vehicle parked in the premises of Jagatsinghpur Municipality in between 10.30 A.M to 5 P.M on any working day before submitting the tender. Each tender must accompany an earnest money deposit against each vehicle only in shape of Bank draft of any Nationalized bank in favour of Executive Officer, Jagatsinghpur Municipality, Jagatsinghpur which will be refunded to the unsuccessful tenderers, except of successful tenderer. The RTO, Jagatsinghpur have fixed the auction sale of the vehicle. The bid/tender price offered shall not be less than the off-set price fixed by the RTO/Off-Set Price.

The tender should reach the undersigned by registered post/speed post from 21.08.2022 up to 28.08.2022 by 5.00 P.M at the latest. The tender paper received shall be opened by the Tender committee in the office chamber of Chairperson, Jagatsinghpur Municipality, Jagatsinghpur on **29.08.2022 at 11 A.M** in the presence of the renderers or their authorized representatives. The undersigned will not held responsible regarding late submission /receive of tender in any manner.

The highest tenderer, whose tender will be accepted, shall deposit the total amount within 3 days of the disposal of the vehicle whichever is earlier. **In case he/she fail to make deposit of the total amount as per the tender within stipulated time, the deposit earned money shall be forfeited.** If the successful Bidder will not deposit the bid amount and other formalities then the second highest Bidder may be illegible to negotiate for the said purpose. The EMD of successful bidder can be refund, after at the time of final payment of the tender value in time.

VAT and GST as admissible shall be paid on the bidding/tender cost by the successful bidder/ tendered.

The successful bidder /tenderer shall take permission and remove the damaged vehicles from Jagatsinghpur Municipality premises within 7 days. On failure to remove the vehicles within the aforesaid time span ground rent @ 1% of the tendered amount shall be charged for each day and the part of the day till removal of the vehicle from the aforesaid place. Tools shall not be delivered with vehicle
