
Jagatsinghpur Municipality offers advertisement rights to interested Registered Agencies/firms/consortium/Business Houses/Individuals having up to date valid registration Certificate, GST, PAN Card, Trade certificate and fulfilling eligibility criteria for participation in this "Quotation for displaying of Advertisement within Jagatsinghpur Municipality area" for obtaining the License for the purpose of displaying any advertisement to public view within Jagatsinghpur Municipality area on Hoardings as specified in Annexure-A for financial year 2022-23 and can be extended if both parties agrees.

The Tenderer has to submit the non refundable paper cost of Rs.2000./ (Rupees Two thousand only) in the shape of Bank draft in favour of Executive Officer, Jagatsinghpur Municipality, Jagatsinghpur.

The quotationer / tenderer is advised to download Technical & financial bid papers i.e. the Quotation call Notice & term conditions, Bill of quantity (BOQ), check list from the District website i.e. www.jagatsinghpur.nic.in. After due fill up of BOQ must be kept in a separate cover by writing the name of agency over the cover. The other tender/ quotation papers as per check list except financial bid/BOQ cost must be kept in another cover by writing the name of agency over the said cover. Then these two type of covers will be kept in one big envelop by writing the word over the envelop i.e. "Quotation for displaying of Advertisement within Jagatsinghpur Municipality area" which will be received through Indian Regd. Post/ speed post only on or before dt. 04/11/2022 by 3.00 PM & same shall be dropped in the sealed Box kept the office chamber of the undersigned and will be entertained only for the selection process. The quotation box shall be opened on dt. 05/11/2022 at 11.30 AM in the office Chamber of the Chairperson in presence of the member of Tender / Quotation committee and the bidders or their authorized representatives. For any type of postal delay the Municipality will not be held responsible. The bid papers received through courier / by hand, shall not be considered for the purpose of this quotation. The tender is invited as per the following terms and conditions. if the opening day happens to be a holiday on any account, then the next working day will be treated as the last date of receipt and opening of the quotation box. This quotation/ tender is subject to the following terms and conditions.

TERMS AND CONDITIONS


1. Jagatsinghpur Municipality shall grant License/permission to the successful bidder, the right for the aforesaid purpose within the area of Jagatsinghpur Municipality, Jagatsinghpur subjects to such restrictions laid under the provisions of Orissa Outdoor Advertisement & Hoarding Policy-2015, Advertisement Policy for Urban Odisha-2013 and such other provisions of law/Notifications/ circulars/ instructions as applicable in this regard.
2. The licence will be valid for a period of one financial year and can be renewed for another one financial years upto three financial year subject to such restrictions laid under the provisions of law as applicable in this regard. The license can be renewed for one years

subjects to 10% price hike in each renewal after review of the satisfactory performance to that effect.

3. The successful bidder after execution of agreement with Jagatsinghpur Municipality shall submit the details of list of Hoarding structures installed for displaying of advertisement with allotted locations within one month. The license holder is to furnish the lists of numbers of hoardings in different allotted places/sites within Jagatsinghpur Municipality area in each three months or as instructed by the authority so as to enable the Municipality to verify the same about such displaying of Hoarding/Advertisement, in conformity with the term and conditions of the agreement. The successful tenderer/ license holder will have to install the temporary hoardings at their own cost in consultation with Jagatsinghpur Municipality, Jagatsinghpur.
4. The intending Tenderers shall quote their own price on or above the upset bid price/amount of **Rs. 3,00,000/-** (Rupees Three lakhs only) as shown in the BOQ/Financial bid. The bidder has to quote the offer rate both in figure and words during fill up the price bid without overwriting. In case of any discrepancy found in rates of figure and word then the rate mentioned in word will be treated as final.
5. The final successful bid amount/ renewal amount shall be deposited in the shape of bank draft in favour of Executive officer, Jagatsinghpur Municipality, Jagatsinghpur. The final successful bid amount / renewal bid amount shall be deposited by the license holder in the month of March before starting of next financial year i.e. from 1st April. After prior deposit of final successful bid amount/ renewal amount, the license holder/ successful bidder shall be permitted to install the hoarding / advertisement by the authority otherwise it leads to cancel the bidder as license holder of the Jagatsinghpur Municipality.
6. In case, the first successful bidder fails to comply the conditions of the tender and unable to deposit the final successful bid amount at a time before execution of the agreement within the period as specified in the intimation letter. Then the second successful bidder shall be taken into consideration subject to compliance of the conditions of the Tender and the authority may adopt the principle of negotiation in comparison with the quoted rate of first successful bidder. After all usual process the agreement will be executed. No instalment or part payment of the final bid amount is allowed. The final bid amount once deposited can not be refunded but can be adjusted to the license Holder in part or full.
7. In course of period of operation of agreement, if it is found to the satisfaction and information of the authorities that there is any violation of the terms and conditions of the contract/ agreement/rule & regulations by the license Holder /successful bidder, in that event the contract may be terminated with show cause notice and Jagatsinghpur Municipality, Jagatsinghpur shall be at liberty to take possession of the advertisement properties as per law.
8. The intending Agencies/firms/consortium/Business Houses/Individuals who are defaulters in paying any of the Tax/dues of the Jagatsinghpur Municipality, Jagatsinghpur shall be disqualified for participating in the bidding.

9. The agency will be liable to pay such other Government dues/ fees as will be levied to such authority on its own responsibility without burdening the Jagatsinghpur Municipality, Jagatsinghpur on that count.
10. The necessary energy charges to that effect will be borne by the license Holder/successful bidder. The successful bidder/ license holder will only receive the rate/fee as specified in the council resolution shown in Annexure-A. The rate approved / received by the Govt. & District Administration can only override the rate as specified in the council resolution .
11. The number of sites / places of installation of a temporary Hoarding as Shown in Annexure-A can be reduced or increased by the permission of the authority . The said situation will not effect the final bid amount. The sites can be changed with the instruction of Govt.
12. The quotationer who have not deposited Paper cost and required documents/ papers and certificate as per check list , then she/he will be debarred to participate in the quotation. Before execution of the agreement the successful bidder will submit the original papers of which papers/ document submitted by way of photo copy at the time of applying in quotation.
13. Bidder should enclose an affidavit in original declaring that he/she have not been blacklisted by any authority/agency /office/ULB and the documents /Certificates /Papers produce by him/her are true . He/she is not in a list of defaulter of the Municipality and no false information have been given by him/her in the said Affidavit. The bidder/ Quotationer should provide e-mail address, contact No. and postal address for any correspondence.
14. the license Holder / successful bidder will remove / displace the hoardings during the time of emergency such as cyclone , elections and in other event as intimated by the authority , Govt. District Administration for the interest of general public.
15. The tender papers without being accompanied with paper cost and other requirements the said bid shall be summarily rejected.
16. Offer Rates should be inclusive of GST, all taxes, freight, transportation, Labour cost, charges and other fees as imposed by the Govt. from time to time.
17. The successful bidder shall bear the loss/damage caused to the life & property directly & indirectly during the process of installation of hoarding & thereafter. The civil & criminal actions will be dealt by the license Holder / successful bidder. The Municipality is no way responsible for any type of loss/damage and action during the time of installation of hoarding/ advertisement and thereafter.
18. Those agencies are eligible/ successful after finalization/ checking of papers submitted as per the eligibility criteria, can only participate in the Financial bid. The financial bid as given in the 'Bill of quantity-BOQ', will be opened for final selection of Agency subject to other conditions .Due to any breach of term & conditions as above, the process of quotation as well as the final result of the quotation will be cancelled.




