



- 2 The bidder must be accompanied by EMD/ tender security amount of Rs. 2,000.00 (Rupees:- Two thousand) Only in shape of DD drawn on any Nationalized Bank in favour of Executive Officer, Jagatsinghpur Municipality payable at Jagatsinghpur.
- 3 The sale of tender documents start from dt. 03.11.2022 to Dt. 10.11.2022 up to 5.00 PM. Request for tender/quotation documents through post will not be entertained.
- 4 The sealed tender/quotation documents should reach through the registered post or put in the drop box office of the Executive Officer, Jagatsinghpur Municipality, Jagatsinghpur on or before dt. 11.11.2022 by 12.00 Noon positively. The authority will not be responsible for any delay for non receipt of tender/ quotation documents in time.
- 5 The tender/ quotation/ bid documents will be opened on dt. 11.11.2022 at 3.00 PM in the office chamber of Executive Officer, Jagatsinghpur in the presence of the bidders or their authorised representatives who wish to attend.
