**INSTRUCTIONS TO THE CANDIDATES**

1. Please bring the Intimation Letter with your photograph, Government approved valid Photo Identity proof in original and its photocopy (which includes Voter Identity Card, Driving License, PAN Card, Passport, Aadhar Card), one black/blue ball point pen, transparent water bottle and mask to the examination centre.
2. Any kind of digital and manual wrist watches shall not be allowed in the examination premises.
3. Use of books, notebooks, pouch, pencil box, bags, money purse, calculators, wrist watch, bracelet, metallic items, pagers, mobile phones, electric gadget and any other device which will help the candidate to manipulate the test shall not be permitted. Candidates are advised not to bring any of the above mentioned banned items to the venue of examination. District Administration shall not be responsible for safe keeping of any valuable item of the candidate.
4. Any candidate found resorting to any unfair means or malpractice or any misconduct while appearing for the test including giving/receiving help to/from any candidate during the examination will be disqualified.
5. Any request for Centre change / date change will not be entertained.
6. Candidates should reach at the test venue in time as instructed in the Intimation Letter.
7. Candidates will neither be allowed to enter the test venue after the Gate Closure Time nor permitted to leave the venue before completion of the test.
8. Anyone found to be disclosing, publishing, reproducing, transferring and storing of test contention in any form in whole or part by any means verbal, written, electronic, mechanical or taking away the papers supplied in the examination hall or found to be in unauthorised possession of test content is likely to be prosecuted as per Law and his/her candidature shall be rejected.
9. Mere appearance in the Examination does not confer any right to selection for the post applied.
10. The candidature of the applicant shall be cancelled if he/she remains absent in Computer Practical Skill Test.
