Sealed tenders are invited from interested reputed Travel Agencies/Tour Operators of Private individuals of providing one **TUV300/Mahendra Bolero/Sumo Gold/Ertiga** vehicle which shall conform to the terms and conditions (Annexure-II) for official use in the office of the Tahasildar Tirtol on monthly rental basis.

1. The vehicle must be in road worthy condition shall not be more than 2 years old from the date of initial registration and must have Registration certificate, insurance certificate, fitness certificate, valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of 5000/- shall be deposited by the intending bidders in shape of account payee Bank draft drawn in favour of Tahasildar Tirtol and submitted along with the tender as security deposit. After completion of tender process the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
6. The hire charge of the vehicle & other terms and conditions will be as per latest notification of Finance Department vide letter no. 30464/F Dated. 06.09.2019.
7. The details of the make and year of manufacture of the vehicle registration on mileage (Kms covered per liter) and name of the driver of with driving license No. and period if validity should be specifically provided in the general bid information to be furnished with the quotation (Annexure-II)
8. The Quotation/Tender completed in all respect should reach the undersigned on or before dt. **16.12.2022** by 4.00 P.M and shall be opened on **same day at 4.30 P.M** in presence of the bidders or their authorized representatives in the office chamber of Tahasildar chamber Tirtol.
9. The bidder must furnished duly signed term and conditions (Annexure-I) along with application in Annexure-II.


