## VEHICLES FOR AUCTION SALE

Sealed quotations in plain paper/letter head are invited by the undersigned for auction sale of Mahindra Jeep(Disel) bearing regd. no **OR-02-A-3300** under Agril. department.

The intending bidders may inspect the vehicles in the office premises of the undersigned located at Nimakana village, Tirtol prior to submission of tender paper by them in any working days during office hour.

The sealed tender will be received upto 2.00 PM on **30.12.2022** and will be opened by the undersigned on **30.12.2022 at 4.00PM** in the office chamber in presence of the bidders or their authorized agents . If the mentioned date for opening of tenders is declared as Government Holiday, the tenders will be opened on the next working day on the scheduled time .

The intending bidders are requested to deposit Rs.1000/- (Rupees one thousand) only as E.M.D in shape of Demand Draft in favour of Agriculture District Officer, Tirtol payable at Tirtol . Quotations received without EMD or EMD in a form other than Demand Draft will not be considered at all . EMD money received from the bidders will be returned to unsuccessful bidders without interest immediately after the process of selecting the highest bidder is over . Quotations received after due date and time will not be accepted.

The highest rate quoted by the bidder above the upset price shall be accepted and confirmed. The purchaser is liable to pay GST along with cess as per applicable rate on the bid amount. The highest Bidder is required to deposit 25% of offered amount of the vehicle immediately after the sale is confirmed and the rest amount within 7 days from the date of acceptance of tender. If the highest bidder fails to deposit the balance amount within above stipulated time, the deposited amount will be forfeited . The successful bidder shall have to remove the vehicle from the present premises within 7 days from the date of depositing the full amount of the tender money failing which the Department will not be responsible for any damage. The ground rate @1% of the tender amount shall be charged for each day of delay after lapse of stipulated period till removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, the bidder shall cease to have any right on the vehicle and the amount deposited by him/her shall be adjusted towards ground rent.

The Upset price fixed by MVI, Jagatsinghpur for the vehicle **OR-02-A-3300** is **Rs.18000/-**.
