**ELIGIBILITY CRITERIA FOR ENGAGEMENT OF CRCC ON DEPLOYMENT**  
**BASIS**

Application is invited from eligible and competent elementary cadre teachers Level- V Teacher for engagement of Cluster Resource Centre Coordinator on deployment basis. The eligibility criteria for the post of Cluster Resource Centres Coordinator are as follows.

- i. He/ She should have at least 06 years of teaching experience.
- ii. He/ She shall have 05 years of service before retirement.
- iii. Teacher in Level -V are eligible for applying for the post of CRCC and He/ She should have 5-Years left for retirement.
- iv. He/ She are presently residing in the block in which He /She shall be engaged as CRCC.
- v. He/ She should belong to level- V of elementary education cadre teacher.
- vi. As per the Letter No.6446/TT/18, dated.06.07.2018 of Additional Director, Planning, OPEPA, The regular level-V Assistant teachers(Ex- cadre) will not be considered for the selection of the post of CRCCs.
- vii. The teacher having departmental proceedings/ Charges of misappropriation of fund/ criminal case pending shall not be eligible to apply.
- viii. Those teacher who have been disengaged/ reverted from the post of CRCC due to different reasons i.e poor performance/completion of 05 years as CRCC under SS and misconduct etc, shall not also be eligible to apply.
- ix. Teacher Who have already completed 5- years of Service as CRCC are not eligible to apply( Letter No.10219, Date.19.12.2007& Letter No.10937, Dated.11.12.2014 of SPD, OSEPA)
- x. She should have proficiency in subject based competencies.
- xi. She/ He should have dynamic and positive attitude towards project work.
- xii. She/ He will be engaged as CRCC for a period of 5-Years on the basis of visioning Test. After completion of 5- year of tenure, She/ He will reverted back to their parent post.
- xiii. If any allegation or inefficiency found or detected before the appointment or during his/ her service as CRCC, She/ He will reverted back from the said post.
- xiv. In- Charge CRCC of different cluster are directed to apply against their cluster in proper forum.

**Process of Selection**

For smooth conduct of the selection process the following criteria has been prepared. The criteria for the appraisal of performance of CRCCs may be quantified as follows.

- (i) Teachers have to appear and qualify visioning test, GD & Viva Test which is a part of selection process.
- (ii) The visioning test will be conducted mainly covering subjects from elementary text book and methodology and SS related interventions. There will be a merit list of successful candidates on the basis of performance in written test, Group Discussion,& Viva Test.
- (iii) The panel will be block wise and no reservation policy/principle will be followed since it is an internal deputation post.
- (iv) The guideline of OSEPA in respect of financial benefits to CRCCs will be strictly followed.




