

PROCEEDING OF THE PRE BID MEETING HELD ON 17.01.2023 AT 4 P.M. UNDER THE CHAIRMANSHIP OF THE COLLECTOR & DISTRICT MAGISTRATE, JAGATSINGHPUR IN SADBHAVANA SABHAGRUHA, COLLECTORATE, JAGATSINGHPUR FOR ENGAGEMENT OF COMPREHENSIVE FACILITY MANAGEMENT SERVICES IN SPL.CIRCUIT HOUSE, PARADIP.

A pre- bid meeting was held on 17.01.2023 4 P.M. in the Sadabhavana Sabhagruha, Collectorate, Jagatsinghpur under the chairmanship of the Collector & District Magistrate, Jagatsinghpur to discuss and meet various queries of intended bidders on engagement of CFMS in Spl.Circuit House, Paradip. The members present in the pre-bid meeting are as follows:-

1. Collector & District Magistrate, Jagatsinghpur
2. Additional District Magistrate (Admn), Jagatsinghpur.
3. Asst. Collector, Nizarat, Collectorate, Jagatsinghpur.

The queries have been received from three bidders for clarification, out of which one bidder named Group No.5 Security service, Rasulgarh Bhubaneswar was present through it's authorized representative and two other bidders have submitted their queries through E-mail i.e. S.S. Service, Bhubaneswar & M/s U.Tech Service, Bhubaneswar. At the outset the Asst. Collector, Nizarat, Collectorate, Jagatsinghpur welcomed all the members including the authorized representative of the bidder and provided him the copy of the Model Request for Proposal.

The query of Sri Raghunath Behera authorized representative of the bidder Group No.5 Security service, Rasulgarh Bhubaneswar is mentioned as follows :-

Query not accepted. As these formats have been made by Revenue, & Disaster Management Department Govt. of Odisha could not be modified. So the bidders should furnish the detail break up for the Financial Offer in Form-F3 for the sanctioned posts only.

The bidder requested for exemption of bid processing fees as this firm was registered under MSME Department & NSIC .	Query not accepted. The clarification for exemption of bid processing fee should be sought from the MSME Department, Govt. of Odisha, after receipt of the clarification from MSME Department, Govt. of Odisha this request should be considered.
