

Sealed tender in plain paper/letter pad are invited from intended registered firms having GST for supply of Engine Control Unit (ECU) for Mercury 25 HP 4 Stroke Engine of Power Boats with the following terms and conditions. The quotation document can be collected by the interested intending supplier/firm by hand from the office of the District Emergency Operation Centre, Jagatsinghpur on deposit of cost of quotation processing fee i.e. Rs.400/- in shape of A/C payee demand draft drawn in favour of "Collector, Jagatsinghpur" on any Nationalized Bank/ Scheduled Bank payable at Jagatsinghpur (Non-refundable). The quotation document can be downloaded from District website i.e. <https://jagatsinghpur.nic.in>. While applying through such downloaded form, it must be accompanied by DD of Rs. 400/-.

The tender should be submitted in a sealed envelope super scribed in as 'supply of Engine Control Unit (ECU) for Mercury 25 HP 4 Stroke Engine of Power Boat' containing the tender and must be delivered to the District Emergency Operation Centre, Collectorate, Jagatsinghpur on or before 22.02.2023 by 1.00 P.M. through Registered Post/Speed Post of Indian Postal Deptt. or dropped in the assigned box at the District Emergency Operation Centre, Collectorate, Jagatsinghpur. No other mode of delivery shall be accepted. The tender received after the stipulated date & time shall not be entertained. The tender will be opened on the same day at 4.00 P.M in the office chamber of the Additional District Magistrate, Jagatsinghpur in presence of the members of the Tender Committee and the tenderers or their authorized representatives.

TERMS AND CONDITIONS OF THE TENDER CALL NOTICE

1. The intending Tenderer must be bonafide registered body having valid GST Registration No. and latest IT return supported documents. Self attested photo copy of the GST registration certificate and IT return should be attached.
2. The intending Tenderer should have valid PAN Card. Attested photo copy of PAN Card should be attached.
3. The approved Tenderer should have to supply the materials in the locations i.e. at Alipingal of Jagatsinghpur Block, Biridi Block and Balikuda Block at his own cost.
4. The Supplying Agency must not have been blacklisted by any Govt. organization. (Attach declaration in Stamp Paper of Rupees Ten).
5. The rate quoted by the bidders shall be valid for the period of one year from the date of Signing of agreement/finalization of the Tender.
6. The materials needs to be supplied by the suppliers within 03 (three) days in the locations i.e. at Alipingal of Jagatsinghpur Block, Biridi Block and Balikuda Block from the date of receipt of supply order for which the terms should be committed.
7. Failure to supply the order in full within the stipulated period from the date of issue of supply order amounts to cancellation of order automatically.
8. If any dispute arises, the matter shall be referred to Tender committee for settlement of dispute.
9. The Tenders received in incomplete form or after the Scheduled date & time shall be summarily rejected.
10. The price quoted with GST to be submitted.
11. The materials will be guaranteed by the supplier against any defect for a period of 12 months from the date of supply or 6 months from the date of use, whichever is later. Guarantee certificate in this regard will be accompanied with supply of materials. If any defect is found in the materials within the guarantee period, the same will have to be replaced free of cost by the supplier.

12. The successful quotationer shall have to furnish a performance bank guarantee for 3% of value of materials within 07 days from the date of issue of Purchase Order. The Bank Guarantee shall be released after completion of the guarantee period and clearance from proper authority.
 13. The quotationer should quote appropriate taxes with the offer.
 14. The rates and amounts should be quoted both in figures and words in the price schedule. Any correction or overwriting in the specification and price schedule should be duly certified by the tenderer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered. In case of any mismatch in rates and amount, the rate will be considered.
 15. Price escalation will not be allowed under any circumstances. The quoted rates will remain firm till execution of the work order.
