



### TENDER CALL NOTICE

Sealed tender in plain paper/ letter pad are invited from intended Person/Agency having GST for installation IEC hoardings for awareness of registrant public with the specifications as below :

1	Earth work in foundation plt for erection of iron hoarding structure with lead & lift 4x ( 2' x 2')	
2	Cement concrete (1:2:4)	
3	Erection of Iron structure for Flex mounting	
4	Preparation of Flex as per approved design & mounting on Iron structure	



The tender should be submitted in a sealed envelope super scribed in as "tender for IEC Hoarding" containing the tender and must be delivered to the District Sub-Registrar Office, Jagatsinghpur on or before 24.02.2023 by 01.00PM through Registered Post/ Speed Post of Indian Postal Department or dropped in the assigned box at the District Sub-Registrar Office, Jagatsinghpur. No other mode of delivery shall be accepted. The tender received after the stipulated date and time shall not be entertained. The tender will be opened on the same day at 5.00PM in the office chamber of ADM-cum- District Registrar, Jagatsinghpur. The authorized agents may remain present at the time of opening of the tender.

#### Terms & Conditions of the Tender Call Notice

1. The intending Person/Agency must be bonafied registered body having valid GST Registration No. and IT return. Self attested photo copy of the GST registration certificate and IT return should be attached.
2. The intending Agency/ person should have valid PAN Card. Attested photo copy of PAN Card should be attached.
3. The approved Agency/ person should have to supply the materials in this office at his own costs.
4. The supply Agency must not have been blacklisted by any Govt. organization. (Attach declaration in Stamp Paper of Rupees Ten)
5. The price quoted by the bidders shall be valid for the period of one year from the date of signing of agreement/ finalization of the tender.

6. The required quantity of materials need to be supplied by the suppliers within two days in the District Sub-Registrar Office, Jagatsinghpur from the date of receipt of supply order for which the terms should be committed.
7. Failure to supply the order in full within the stipulated period from the date of issue of supply order amounts to cancellation of order automatically.
8. If any dispute arises, the matter shall be referred to purchase committee for settlement of dispute.
9. The tenders received in incomplete form or after the Scheduled date & time shall be summarily rejected.
10. The price quoted with GST to be submitted.
