It is informed that, the undersigned has announced the Award in respect of the said land under Section 3(G) of the NH Act. 1956 vide order dated 05.01.2023 and 13.02.2023.

The land acquiring agency (MORTH) approved the estimate. Notices have also been issued to the concerned land owners/interested persons as required under Section 3(E) of the NH Act.1956.
