District Magistrate, Paradip-Cum-Chairman, RMC Rahama invites percentage Rate bids in **Single Cover (S.I No.1)** in online mode for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-7 (Seven) registered with the state Governments and contractors of equivalent Grade/ Class Registered with Central Government /MES/ Railway/CPWD for execution of works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.

The Tender Paper cost and Earnest Money Deposit/ Bid security of the amount specified for the work in col.05 and 06 above, the bidder shall make electronic payment using his/ her Internet enabled account with designated Bank or their aggregator Bank such as SBI/ Union Bank/ ICICI/ Canara Bank/ HDFC or bidder having account in other bank can make payment using NEFT/ RTGS facilities of designated banks. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the State are required to furnish 2% of the amount put to tender as Bid Security.

6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class- II or Class- III.
7. Bids shall be received only "On line" on or before Dt. **22/06/2023** up to 4:00 PM. .
8. Bids received on line shall be opened at 11:00 AM on Dt. 23 / 06 2023 in the office of the RMC Rahama At/ P.O.- Rahama Dist.Jagatsinghpur in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of the bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening the bidders as specified, the bids will be opened on the next working day at the same time and venue.
9. After the date and time of receipt of bid is over. The original affidavit regarding authentication of the documents shall be submitted in the office of the Regulated Market Committee, Rahama
10. The Cost of bid documents as mentioned in Column 6, the bidder shall make electronic payment using his/ her Internet banking enabled account with designated Bank of their aggregator Banks SBI/ Union Bank/ ICICI/ Canara Bank/ HDFC or bidder having account in other bank can make payment using NEFT/ RTGS facilities of designated banks.

The Engineer contractor willing to avail the Exemption of EMD will submit scan copy of the affidavit to avail the exemption along with bid document and original affidavit will be submitted before opening of the Technical Bid. Affidavit should contain how many times such facilities have been availed by him prior to this during the current financial year. Otherwise they will not be entitled to avail such facilities.

12. The bidder should have carried out at least one construction work of providing and laying factory made cement concrete interlocking paver blocks of minimum 5000 SQFT in any Govt. Departments.
