Expression of Interest (EOI) for Engagement of Block Level Community Based Organization (CBO) for "Implementation of Delta Agriculture Action Plan".

Department of Agriculture & Farmers' Empowerment, Government of Odisha is implementing a Programme for Implementation of Agriculture Action Plan under Mahanadi Delta-I & II in 06 Blocks namely Jagatsinghpur, Raghunathpur, Biridi, Tirtol, Kujang & Erasama of Jagatsinghpur District.

1 Background:

Mahanadi Delta Stage –I and Stage-II covers mostly 34 blocks of 6 Districts namely Jagatsinghpur, Kendrapada, Cuttack, Khordha and Puri. The irrigation potentials have been created since 2008-09 to 2022-23 in different phases under Mahanadi Delta Stage-I and II.

- Under Stage I, the design Cultivable Command Area (CCA) is 125767 Ha, the irrigation potential created for 125767 ha in the Districts of Cuttack, Kendrapada, Jajpur and Jagatsinghpur.
- Under Stage-II, irrigation potential created of 151030 Ha in the Districts of Khordha and Puri.
- In total, the irrigation potential created in Delta Stage I + II, the designed CCA is 276797 Ha
- Out of the Stage I designed CCA 125767 Ha, near about 47414.80 Ha designed for Jagatsinghpur (6 Blocks).

2 Major Objectives of the Programme:

1. Improvement usage of Irrigation water for Rabi and Summer Crops under Mahanadi Delta Stage-I.
2. To know the certified/ verified Cultivable Command Area (CCA) under Delta-I.
3. To compare the irrigation plan with existing cropping pattern.
4. To prepare cropping plans for verified CCA for Rabi and Summer crops.
5. To sensitize farmers on availability or irrigation water in the ayacut and its utilization.
6. To prepare real time Scheduling of Irrigation water with timeline to release.
7. To make a real time Agriculture Action plan for optimal utilization irrigation water taking suitable crops in the designed CCA.

8. Plan for scheme convergence and timely prepositioning the Agri inputs for the Farmers.

4 Role and Responsibilities:

- CBO will ensure implementation of Action Plan
- CBO will implement the Action plan in coordination with Farmers and progressive farmers.
- CBO to make farmers awareness about the types of crops to be grown, crop insurance, Soil testing, Arrival of seeds, Release of water by DoWR.
- CBO to ensure the registration of farmers in Krushak Odisha Portal/GO-SUGAM
- CBO to make the clusters, make value addition, Market linkage, Scheme convergence etc.

5 The Expression of Interests (Eol)

This Expression of Interest (EOI) is invited by the Chief District Agriculture Office, Jagatsinghpur district from the experienced and interested CBO (CBO may be Farmer Group /CIG /FPO /SHGs/ Cooperative/ any other Local community Institution or organization) for engagement at block level for the 06 blocks Jagatsinghpur, Raghunathpur, Biridi, Tirtol, Kujang & Erasama Block of Jagatsinghpur district under the Programme for Implementation of Agriculture Action Plan under Mahanadi Delta-I are required to submit application in sealed envelope super scribed as "Application for engagement of block level Implementing Agency for Agriculture Action Plan under Mahanadi Delta-I & II" along with name of the Block and District applied for as per the enclosed application format by registered/ Speed post only to the office of the undersigned. Proposal through e-mail or any other means will not be entertained in this regard. The Eol should be addressed to Office of the Chief District Agriculture Officer cum Project Director ATMA of Jagatsinghpur District. **Last date for receipt of proposal is 02.12.23 up to 1.00 P.M and the same shall be opened on 05.12.23 at 10.00 A.M in the presence of authorized signatory and representatives.**

The Authority shall not be responsible for any sort of postal delay and proposal received beyond scheduled date & time shall not entertained and out rightly be rejected. The authority reserves the right to cancel / reject any or all the EOI without assigning any reason thereof.

6 The Eligibility Criteria for the CBO

6.1 Criteria for registered CBOs :

1. Should be legally registered under Trust/ Society/ Company act or recognized by any govt agency.
2. Should provide a self-attested copy of registration, PAN number and self-attested copy of PAN card.
3. Should not have been blacklisted by Government of India, state government of Odisha, other government agencies and any Indian or international donor and provide a self-declaration by the authorized representative to this effect.
4. Should have last 3 years' Financial Reports submitted to the concerned regulatory authorities.
5. CBOs should be interested to be involved with the project activities and should submit a letter of intent along with resolution to the Collector and District Magistrate, Jagatsinghpur.
6. The CBO should have minimum land and infrastructure required for implementation of Agriculture Action Plan in the specified block under in Mahanadi Delta Area in coordination with farmers, progressive farmers
7. The CBO should have a team leader, a mobilize and two field assistants for working for the said programme

8. Must be willing to incur the operational cost of the programme till the fund is released. And should be willing to work on the non-budgeted activities as specified by the programme.
9. The chief functionary of the institution should not be a formal member of any political party and furnish an undertaking to this effect.
10. Should not have more than one-third of the Governing Body members related to each other and no staff members related to each other should be supervising each other.
11. Must have worked with any of the government program in the proposed block
12. One FPO is eligible for applying for two contiguous blocks.
13. Preference may be given to the CBOs having similar nature of work with good performance and experience working with farmers or Agricultural/ Horticultural Govt. Schemes.

The format of Eol is in Annexure-2 and The CBOs need to apply in the specified format only. Copies of the following documents need to be submitted along with the Eol form and all the documents should be signed with seal at each page.

- Registration certificate
- Previous 3 years Audited statement of accounts for 2019-20, 2020-21, 2021-22
- Previous 3 years Annual Report 2019-20, 2020-21, 2021-22
- A letter of intent along with resolution addressed to the Collector and District Magistrate, Jagatsinghpur.
- Proof of Minimum land and infrastructure availability in the specified Block
- Fixed asset position including its present value and location.
- Profile of professional staff of the organization.
- MoU/ agreement/ any documentary evidence of working for Govt. or special projects or Govt. undertakings of implementing the programme of **Last Five years Only**
- Address of head and field offices.

6.2 Criteria for non-registered CBOs (WSHG Federations)

Following are the mandatory eligibility criteria for selection of Community Based Organization (CBO) for non-registered CBOs (WSHG Federations):

1. CBO must be functional for a minimum of 2 years. In case of recently formed FPOs/ Federations/ Cooperatives, member CBOs should be functional.
2. CBO must not have defaulted loans from any governmental or non-governmental sources such as OLM, OTELP, NABARD, Micro finance etc.
3. CBO should have a president and secretary who must have minimum literacy skills. Signatories of the CBO must possess reading and writing skills in Odia. Reading and



writing skills in Hindi and English will be considered an added advantage. They should be able to sign on the bank passbook.

4. CBO must have a history of conducting regular meetings with documented minutes.
5. CBO meetings should have happened at least once in every quarter.
6. CBO members (At least 10 members or half of the membership whichever is less) must have collectively involved in either inter-lending or some business or production related activity.
7. CBO must have maintained books and accounts and relevant registers.
8. CBO must have done transactions worth at least Rs 100000 till now.
9. CBO must be willing to incur the operational cost of the programme till the fund is released. And should be willing to work on the non-budgeted activities as specified by the programme.
10. CBOs should be interested to be involved with the project activities and should submit a letter of intent along with resolution to the Collector and District Magistrate, Jagatsinghpur.
11. The CBO should have minimum land and infrastructure required for implementation of Agriculture Action Plan in the specified block under in Mahanadi Delta Area in coordination with farmers, progressive farmers
12. The CBO should have a team leader, a mobilize and two field assistants for working for the said programme
13. Preference may be given to the CBOs having similar nature of work with good performance and experience working with farmers or Agricultural/ Horticultural Govt. Schemes.

The format of Eol is in Annexure-2 and CBOs/WSHG Federations need to apply in the specified format only. Copies of the following documents need to be submitted along with the Eol form and all the documents should be signed with seal at each page.

7 Process of Selection:

- **Stage 1:** Short listing of at least three applications per block from the received applications after a scrutiny by the District Level Selection Committee. In case there are less than three applications received per block then the application shall be taken into consideration for short listing with prior approval from the CDAO-cum-PD ATMA.
- **Stage 2:** Out of the three CBOs shortlisted per block after the scrutinization by the team , the Selection Committee chaired by CDAO-cum-PD ATMA will select one CBO through document verification and score sheet.
- **Stage 3:** After the document verification, an assessment shall be done based on the scoring sheet and one CBO shall be recommended as the Implementing Agency for the proposed block. The CBO recommended by the committee for the proposed block shall be submitted for approval of the Collector & District Magistrate.
- **Stage 4:** After completion of selection of CBO, MoA will be signed between CDAO-cum PD ATMA, and selected CBOs for the Project so as to start the activities immediately.


