- 1 The intending registered Agencies must be bonafide registered body having valid registration number. Attested photocopy of the registration certificate should be attached.
- 2 The organization should have PAN, valid GST number and up to date GST clearance certificate. Attested copies of PAN, valid GST number and GST clearance certificate should be attached.
- 3 The tenderer must not be blacklisted by any Govt. organization. (Attach declaration / Affidavit in Non Judicial Stamp Paper of Rupees Ten).
- 4 The tenderer has to enclose a Demand Draft amounting to Rs.1000.00 (Rupees One Thousand) only (Non refundable) towards cost of tender paper in favour of District Child Protection Unit, Jagatsinghpur from any Nationalized Bank payable at Jagatsinghpur.
- 5 The successful bidder is/are required to deposit performance security in shape of Bank Draft / Demand Draft pledged "in favour of **District Child Protection Unit, Jagatsinghpur**" which will be refunded after payment of final bill as follows.
 - i) For fixation of Signage in High Schools : Rs. 20,000/-
 - ii) For fixation of Signage in Temple/Religious Places : Rs. 10,000/-
 - iii) For fixation of Iron Hording in PHCs : Rs. 23,500/-
 - iv) For fixation of all the above items in case of one successful bidder : Rs. 53,500/-
- 6 The Tenderer may participate/quote their rates for any one or two or for all the items.
- 7 Rate should be quoted per unit against each item inclusive of all expenditure including taxes as applicable along with Signage, flex, iron frame cost, fixation of hording and transporting charges etc.. The defective, improper and damage items must be re-fixed/resupplied by the organization.
- 8 The Tender paper should be filled in properly and legibly without any correction / overwriting and signed by the tenderer in each page of the document. The rate per Unit of should be written both in figures and words in the Quotation Form i.e. Financial Bid (placed at Annexure-B.)
- 9 **The tenders will be opened on dt. 18.09.2023 at 05:00 P.M. in the office chamber of Additional District Magistrate, Jagatsinghpur** in presence of the Tenderer or his/her authorised representative.
- 10 The successful bidders have to complete supply, fixation of Signage and Hoardings with flex banner display work at different schools, temples/religious places and PHCs of Jagatsinghpur District within 30 days from the date of issue of work order from the District Child Protection Officer, Jagatsinghpur.

- 12 Quality and Specification of the items shall not be compromised in any manner.
- 13 The bidder who qualifies in technical bid will be eligible to participate in financial bid.
- 14 The Agency finalized for supply and fixation of Signage and Flex hoardings has to obtain the soft copy of design/materials for printing and list of school, temples/religious places and PHCs of Jagatsinghpur district from DCPO, Jagatsinghpur for execution of work.
- 15 The successful agency cannot redesign or modify the Specifications of the Items.
- 16 The successful bidder will get the work order from the District Child Protection Officer, Jagatsinghpur and after completion of work, District Child Protection Officer, Jagatsinghpur will release the payment to the successful bidder.
- 17 If any dispute arises the matter shall be referred to tender committee for settlement of dispute.
- 18 The resultant contract will be interpreted under Indian laws.
- 19 The organizations have to submit an affidavit of declaration for no case pending against him/her under violation of Child and Adolescent Labour Act.
- 20 The authority reserve right to reject any or all the tenders without assigning any reason thereof and shall bear no liability whatsoever consequent upon such decision.


