



5. The tender will be in two parts i.e. Technical Bid (Part-I) & Financial Bid (Part-II). The Bidders should submit their Technical bid and Financial Bid separately in two envelopes and put into another cover super scribing in the capital letters such as "TENDER FOR PRINTING & INSTALLATION OF TIN BOARDS ON MAMATA SCHEME IN PANCHAYAT OFFICES OF JAGATSINGHPUR DISTRICT".

6. The tender paper should be filled in properly and legibly in plain paper/ letter pad without any correction/ over writing.
7. The price of Tin Board (Tin Signage) is to be quoted per piece (Unit) only & must be within Rs.5033/- (Five Thousand Thirty Three rupees) only.
8. The price quoted must be inclusive of Tin material cost/printing cost/all taxes/ duties/ transportation cost/ installation cost at each Panchayat Office/ insurance, excise duty and custom duty (if any). The rate should be written both in words and figures in the tender paper. The rate quoted should be final and any change in the same will not be allowed under any circumstances.
9. The bidders should submit the sample of design along with other required documents while submitting tender and to submit the sample of Tin Boards & frame angles at the time of opening of tender.
10. The tender committee will verify the sample & lowest rate quoted and the tender will be finalized taking into the consideration of both the rate quoted by the firm and quality Tin & Iron Angle materials submitted by the bidders. The decision of the tender committee regarding selection of firm for printing supply & installation of Tin signage at Panchayat Offices will be final.
11. The selected bidder will complete the entire process of preparation, supply and installation of required numbers of Tin Board (Tin Signage) at each Panchayat within 15 days of receipt of the order from DSWO, Jagatsinghpur failure to which may lead to forfeiture of security deposit / imposition of penalty. The item must be neat, clean and of good quality without any violation of the prototypes and specification.
12. The bidder has to give EMD of Rs.5, 000/-(Rupees Five Thousand) only with the tender paper in shape of Demand Draft in favour of DSWO, Jagatsinghpur. No bidder shall be allowed to withdraw his tender/earnest money until the tender is finalized. The EMD of unsuccessful bidders shall be refunded.
13. The successful bidder will deposit an amount of Rs.90, 000 (Ninety Thousand) Only in favour of DSWO Jagatsinghpur as Security Deposit. In case the successful tender refuses/ unable to supply after acceptance of his/her/tender, or withdraw the tender, the earnest money deposited by him/her will be forfeited.

  - c. If required, thickness & quality of the Tin Board & Iron Angle used for the structure will be sent for testing charges will be borne by the successful bidder.


