OFFICE ORDER

In pursuance to the Notification No. 6329/Estt., Dated 14.07.2024 of SPD, OSPEA (published in OSEPA Website), It is for information of all concerned candidates mentioned in the Category wise – Subject wise Select List for the Post of Junior Teacher (Schematic) -2023 published vide OSEPA Notice No. 6265 dt .10.07.2024 that, the list of documents required to be submitted at district level at the time of verification of original documents for the post of Junior Teacher (Schematic)-2023 as mentioned in the Govt. in S&ME Deptt. Resolution No. 20336/SME dtd. 22.08.2023.

The candidates shall submit their original certificate and other documents in the districts personally for verification of documents where his/her name has been placed in the Category wise-Subject wise Select List.

The candidates who have already submitted their documents/ certificates at their respective districts during the documents verification held earlier on 20.01.2024 and 21.01.2024, need not attend the document verification again at their respective districts. For such candidates, certificates submitted by them earlier will be taken into consideration.

The candidates whose name finds place in the Category wise-Subject wise Select published vide OSEPA Notice No. 6265 dt. 10.07.2024 in OSEPA Website, but earlier had not attend the document verification or had attended the document verification with incomplete documents, shall submit their original certificates and other documents in the districts personally for verification of documents where his/her name has been placed in the Category wise-Subject wise Select List.

As per Section 8.5 of the Govt. in S & ME Deptt., Resolution No. 20336/SME dtd. 22.08.2023. Provisional merit list will be prepared after document verification of the candidates. Then objections will be invited from the candidates who are placed in the provisional merit list and rejection list.


2. No other date and the time will be assigned further for document verification.
