The Tender Paper cost and Earnest Money Deposit / Bid security of the amount specified for the work in Col. 04 above, the bidder shall make electronic payment using his / her Internet banking enabled account with designated Bank or their aggregator Bank such as SBI / ICICI / HDFC or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.

6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.

7. Bids shall be received only "on line" on or before dt.04/09/2024 up to 5:00 PM.

8. Bids received on line shall be opened at 11:00 AM on dt. 06/09/2024 in the office of the RMC Rahama, AVP, O.- Rahama Dist.- Jagatsingpur , in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids

after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

The cost of bid documents as mentioned in Column 05, the bidder shall make electronic payment using his / her Internet banking enabled account with designated Bank or their aggregator Banks such as SBI / ICICI / HDFC or the bidder having account in other Bank can make payment using NEFT / RTGS facilities of designated Banks .
