Sealed quotations / tenders are invited from interest reputed Travel Agencies /Tour Operators or private individuals for providing one no of AC Petrol/Diesel driven vehicle (Scorpio/Bolero) having sitting capacity not more than 09 including driver, which shall conform the Terms and conditions (Appendix-A) for official use in the Office of the CSO-Cum-District Manager, OSCSC Ltd., Jagatsinghpur on monthly rent basis.

1. The service provider shall have a valid OGST registration to participate in the tendering.
2. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration certificate, Insurance Certificate, Fitness, Certificate, Pollution Certificate, Valid Contract carriage Permit, proof of up to date tax payment etc. which are mandatory for playing of vehicle.
3. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
4. The driver should be well behaved, gentle and obedient in nature.
5. A sum of Rs.5,000/- shall be deposited by the intending bidders in shape of AccountPayee Bank Draft drawn in favour of the District Manager, OSCSC Ltd., Jagatsinghpur and submitted alongwith the tender paper as security deposit. After completion tender process, the amount will be refunded to unsuccessful bidders
6. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants).
7. The vehicles must achieve a fuel efficiency of 10 (Ten) Kms per litre.
8. The details of the make and year of manufacture of the vehicle, registration no. mileage (KMs covered per litre) and name of the driver with Driving License no. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/Tender (Appendix-B).
9. The Quotation completed in all respect should reach the undersigned on or before 30.11.2024 by 5 PM and shall be opened on the date at 02.12.2024 at 4 PM in presence of the bidders or their authorized representatives.
10. The application form of Quotation/tender containing General Bid information & terms and conditions for hiring of vehicles etc. will be available with the CSO-cum-District Manager, OSCSC Ltd., Jagatsinghpur in the office on payment of Rs.1000/- from dt.16.11.2024 to 30.11.2024. upto 5PM or can be downloaded from odisha from Odisha Govt. website www.Jagatsinghpur.Odisha.gov.in & www.oscsc.in from dt.16.11.2024 to 30.11.2024. In case the application form is downloaded from Govt. website, the applicant shall furnish a Demand draft in favour of the District Manager, OSCSC Ltd., Jagatsinghpur for an amount Rs.1000/- (Rupees One thousand) only towards the cost of application along with the application.
11. The maximum hire charges per month excluding taxes will be **Rs.31000/-** vehicle of similar category or higher segment (Scorpio/Bolero) having same millage can be engaged. Vehicles of higher segment having millage 10 KM per litre of fuel may be given preference as per decision of Tender committee.
