


1. The seized Parboiled Rice will be sold on "as is and where is basis".
2. The seized Parboiled rice will not be sold below the reserve price as mentioned above.
3. The Bidder shall have a registered firm having GSTN No.
4. The intending bidders shall have to deposit a refundable amount of Rs. 1000/- (Rupees One Thousand)only by way of cash with the undersigned before the commencement of the auction as earnest money. The Bidder shall bring proof of the identity in original and one passport size photograph.
5. The EMD will be refunded at the end of the auction process , If the bidder fails to get the seized common parboiled rice in the auction sale .In case of successful bidder, the amount will be adjusted towards the payment of sale proceed of the said Common Parboiled rice.
6. The bidder may verify the said common Parboiled rice between 11.00 A.M to 12.30 PM on dtd.18.08.2025 before the auction. Further, it shall be presumed that the bidders shall inspect the Common parboiled rice before the auction. . The undersigned shall not be responsible and shall not entertain any complaint regarding any defect of common parboiled rice .
7. The amount knockdown in favour the highest bidder shall be deposit by him with the undersigned immediately. If he fail to make his payment , the undersigned will either put up the confiscated common parboiled rice for sale immediately or postpone the sale to any future date and the defaulting purchaser may be debarred from the bidding again and he may be required at once to leave the auction room and the EMD deposited by the unsuccessful purchaser shall be forfeited
8. The bid provisionally accepted by the officer conducting the auction is subject to confirmation of the higher authority .






