- ii. The bidders shall bring proof of identity in original, one passport size photograph & GST certificate of the firm.
- iii. The intending bidders shall deposit a refundable amount of Rs.1000/- cash as EMD.

## Terms & Conditions

- i. The seized common parboiled rice will be sold on "as is and where is basis"
- ii. The bidders shall have a registered firm having GSTIN No.
- iii. The intending bidders shall have to deposit a refundable amount of Rs.1000/- (Rupees one thousand) only by way of cash with the undersigned before the commencement of the auction as earnest money.
- iv. The bidders shall bring proof of identity in original, one passport size photograph.
- v. The EMD will be refunded at the end of the auction process if, the bidder fails to get the seized common parboiled rice in the auction sale. In case of successful bidder, the amount will be adjusted towards the payment of sale proceed of the said common parboiled rice.
- vi. The bidder may verify the said common parboiled rice between 10.00 AM to 11.30 AM on dt.29.08.2025 before the auction. Further, it shall be presumed that the bidders shall inspect the common parboiled rice before the auction. The undersigned shall not be responsible and shall not entertain any complaint regarding any defect of common parboiled rice.
- vii. The amount knockdown in favour of the highest bidder shall be deposited by him/her with the undersigned immediately. If he/she fails to make his payment, the undersigned will either put up the confiscated common parboiled rice for sale immediately or postpone the sale to any future date and the defaulting purchaser may be debarred from the bidding again and he/she may be required at once to leave the auction room and the EMD deposited by the unsuccessful purchaser shall be forfeited.
- viii. The bid provisionally accepted by the officer conducting the auction is subject to confirmation of the higher authority.
- ix. Conditional bid will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted the entire money already deposited by the bidder shall stand forfeited
- x. The common parboiled rice shall be handed over to the successful bidder against 100% deposit of the bid value and after completion of all the required official formalities.
- xi. The successful bidder will arrange for transportation of the common parboiled rice at his/her own expenses. After the delivery of the common parboiled rice the undersigned will not be responsible for any damage of common parboiled rice.
- xii. The undersigned reserves the rights to reject or accept any or all bids partly or completely at any time without assigning any reason(s) thereof.
- xiii. The officers and staffs of F.S & C.W Section and their family members shall not be permitted to participate in the auction.
