In pursuance to Advertisement no. 417 dated- 18.06.2025 & Office Order no.632 dated-08.08.2025 of this office Document Verification (DV) of 35 no. of Applicants out of which 25 no. of Applicants to be engaged as Temporary Enumerator under 7th Minor Irrigation Census & 2nd Census of Water Bodies in Jagatsinghpur District was conducted on 11.08.2025. In DV **3 (Three)** Applicants having ranks **20, 30 & 34** were remain absent. Further **2 (Two)** applicants having rank **24 & 25** later communicated through their Application that they are not interested to conduct the Minor Irrigation & Water Body Census.



The Reseve List Attached in **Annexure-II.** Further the Rank Wise list of Applicants published vide this Office Order No 629 dated-08.08.2025 shall remain valid till completion of the Census Work in the District.

The selected 25 Candidates are hereby offered an appointment to engage as Enumerator on temporary basis for conducting 7th MI Census & 2nd Census of Water Bodies in Jagatsinghpur District with following terms & conditions:-

- I. The appointment is purely temporary in nature & no permanent engagement shall be claimed by candidates in future.
- II. The appointment shall be continued till the completion of the Census in the District.
- III. The remuneration for conducting the census is as per the advertisement/ Govt guidelines & will be paid after completion of the Census in the assigned villages / wards. No additional TA/DA will be provided beyond the prescribed remuneration per Village or Ward.
- IV. No accommodation will be provided by DPMU, Jagatsinghpur for conducting the Census in allotted Blocks.


