Extension of Healthcare (Super Speciality) facility through Engagement of Private Technical Service provider /Hospitals to Provide Super/Specialist Services at Kujang & Atharabanki CHC of Jagatsinghpur District, funded under CSR by IOCL.

Background

In order to strengthen secondary healthcare delivery and ensure availability of Super and Super Specialist services to the rural population, the Office of the Chief District Medical & Public Health Officer, Jagatsinghpur, intends to engage reputed Private hospitals within the State to provide specialist services at designated Community Health Centres (CHCs). As IOCL has extended hands to fund for provision of such services under CSR, so it is proposed to outsource Super/Specialist service through authorized agencies as per Govt Norms selected through EoIs. This Arrangement should include:-

At present, 2 CHCs are catering to a large population and there are several Industries situated in the service area of these 2 CHCs. The system is witnessing a significant rise in patients requiring super specialist services and advanced medical interventions. However, due to non-availability of in-house Super/Specialist doctors and limited infrastructure support, patients are being referred to higher facilities . To assist the health seeking behavior of the people this arrangements is proposed.

2. Scope of Services


The selected private hospitals shall provide qualified Super Specialist/ specialists in the following disciplines at both the CHCs:

Norm

- An EoI is to be floated for selection of Technical Partner, they can render specialist services at the 2 CHCs 3 days per week .
- All the medicines shall be prescribed from NIRAMAYA CHC EDL Only
- Any USG procedure shall be done in accordance to PC PNDDT act
- Any referral of patient to Higher facilities shall only be done by Govt doctors.
- The Outsourcing process will strictly follow all applicable Government guidelines, financial norms.

Additional specialties may be included as per local health needs.

3. Eligibility Criteria

Hospitals submitting EOI must:

- a) Be a registered private hospital with valid license under applicable laws.
- b) Have a minimum of **10** years of operational experience.
- c) Employ qualified specialists registered with the Medical Council of India/State Medical Council.
- d) Demonstrate capacity to provide outreach services in rural/CHC settings.

4. Terms of Engagement


- a) Services will be provided on contractual basis as per Government of Odisha guidelines.
- b) Remuneration/honorarium shall be fixed in line with state health department norms.
- c) Duration of engagement shall be initially for [2] years, extendable based on performance.
- d) Monitoring and evaluation will be undertaken by the CDMO office periodically.

5. Submission of EOI

Interested private hospitals are required to submit their Expression of Interest along with the following documents:

- Hospital profile and infrastructure details.
- List of available specialists with qualifications and registration details.
- Experience in providing similar services.
- Copy of registration/license and statutory compliances.
